



## PRIVACY POLICY:

Social Work Projects UK Limited operates [www.socialworkprojects.org](http://www.socialworkprojects.org) and may operate other websites. It is Social Work Projects UK Limited policy to respect your privacy regarding any information we may collect while operating our websites.

### WEBSITE VISITORS

Like most website operators, Social Work Projects UK Limited collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Social Work Projects UK Limited purpose in collecting non-personally identifying information is to better understand how Social Work Projects UK Limited visitors use its website. From time to time, Social Work Projects UK Limited may release non-personally identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

Social Work Projects UK Limited also collects potentially personally identifying information like Internet Protocol (IP) addresses for logged in users and for users leaving comments on socialworkprojects.org blogs/sites. Social Work Projects UK Limited only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personally-identifying information as described below, except that commenter IP addresses and email addresses are visible and disclosed to the administrators of the blog/site where the comment was left.

### GATHERING OF PERSONALLY IDENTIFYING INFORMATION

Certain visitors to Social Work Projects UK Limited websites choose to interact with Social Work Projects UK Limited in ways that require Social Work Projects UK Limited to gather personally identifying information. The amount and type of information that Social Work Projects UK Limited gathers depends on the nature of the interaction. For example, we ask visitors who sign up at [www.socialworkprojects.org](http://www.socialworkprojects.org) to provide a username and email address. Those who engage in transactions with Social Work Projects UK Limited are asked to provide additional information, including as necessary the personal and financial information required to process those transactions. In each case, Social Work Projects UK Limited collects such information only insofar as is necessary or appropriate to fulfil the purpose of the visitor's interaction with Social Work Projects UK Limited. Social Work Projects UK Limited does not disclose personally identifying information other than as described below. And visitors can always refuse to supply personally identifying information, with the caveat that it may prevent them from engaging in certain website-related activities.

### AGGREGATED STATISTICS

Social Work Projects UK Limited may collect statistics about the behaviour of visitors to its websites. Social Work Projects UK Limited may display this information publicly or provide it to others. However, Social Work Projects UK Limited does not disclose personally identifying information other than as described below.

### PROTECTION OF CERTAIN PERSONALLY IDENTIFYING INFORMATION

Social Work Projects UK Limited discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors and



affiliated organizations that (i) need to know that information in order to process it on Social Work Projects UK Limited behalf or to provide services available at Social Work Projects UK Limited websites, and (ii) that have agreed not to disclose it to others. Some of those employees, contractors and affiliated organizations may be located outside of your home country; by using Social Work Projects UK Limited websites, you consent to the transfer of such information to them. Social Work Projects UK Limited will not rent or sell potentially personally identifying and personally identifying information to anyone. Other than to its employees, contractors and affiliated organizations, as described above, Social Work Projects UK Limited discloses potentially personally-identifying and personally-identifying information only in response to a subpoena, court order or other governmental request, or when Social Work Projects UK Limited believes in good faith that disclosure is reasonably necessary to protect the property or rights of Social Work Projects UK Limited, third parties or the public at large. If you are a registered user of an Social Work Projects UK Limited website and have supplied your email address, Social Work Projects UK Limited may occasionally send you an email to tell you about new features, solicit your feedback, or just keep you up to date with what's going on with Social Work Projects UK Limited and our products. If you send us a request (for example via email or via one of our feedback mechanisms), we reserve the right to publish it in order to help us clarify or respond to your request or to help us support other users. Social Work Projects UK Limited takes all measures reasonably necessary to protect against the unauthorized access, use, alteration, or destruction of potentially personally identifying and personally identifying information.

## **COOKIES**

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns.
